TAKE NOTICE that the Municipality of Huron East Committee of Adjustment will hold a public hearing on:Tuesday December 6th at 7:00 p.m.to consider a proposed minor variance under Section 45of the Planning Act (RSO 1990), as described below and shown on the attached map.

BE ADVISED the Municipality of Huron East considered this application complete on November 24th, 2022.

PURPOSE AND EFFECT:

The purpose of this application is to seek relief from Zoning By-law 52-2006 for the Municipality of Huron East. The property subject to this variance is zoned Community Facility on Key Map 66 of the Huron East Zoning By-law, and designated Community Facility in the Huron East Official Plan.

The purpose of the Minor Variance is to request relief from the Huron East Zoning By-law to recognize a reduced rear yard setback from the required 10m to 2m. The Municipality is proposing to sever the existing property into two separately conveyable parcels, both to be continued to be used for a Community Facility use. At the time of submitting this application, there are no development plans for this property and no further relief from the by-law is being requested.

PROPOSED MINOR VARIANCE:

One minor variance is being requested for this development:

• To recognize a reduced rear yard setback for the existing community facility building, from the required 10m to 2m to the newly created lot line.

A map showing the location of the lands to which this proposed minor variance applies is attached.

EXISTING ZONING BY-LAW PROVISIONS:

Section 34.3 of the Huron East Zoning By-law requires a rear yard setback of 10m.

FAILURE TO ATTEND – If you do not participate in the public hearing, it may proceed in your absence and, except as otherwise provided in the Planning Act, you will not be entitled to any further notice in the proceedings.

NOTICE OF DECISION – If you wish to be notified of the decision of the Committee of Adjustment in respect of this application, you must submit a written request to Jessica Rudy at the address listed below. This will also entitle you to be advised of a possible Ontario Land Tribunal hearing in the event the decision on this application is appealed.
