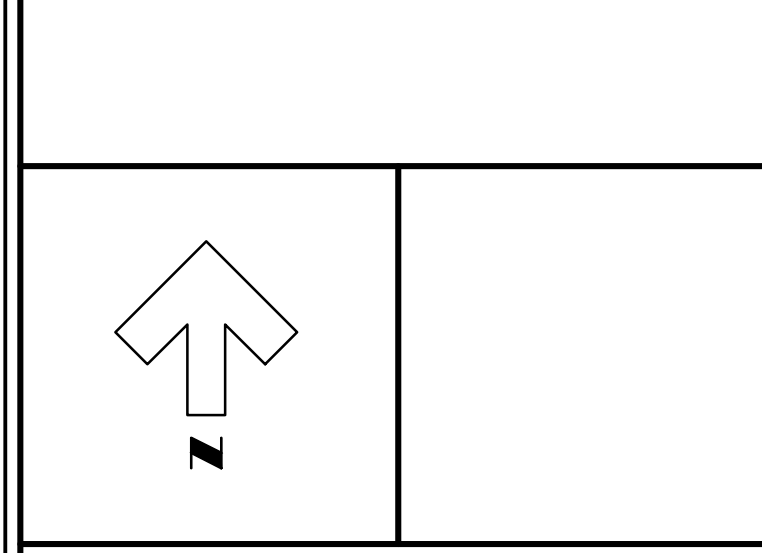

  2. IT IS THE SOLE RESPONSIBILITY OF THE CONTRACTOR TO DESIGN, INSTALL AND MAINTAIN THE REQUIRED TRAFFIC CONTROL SYSTEM. DETOUR ROUTE PLANS PROVIDE A BASIC ROUTE FOR THE DETOUR ONLY. ADDITIONAL SIGNAGE WILL BE REQUIRED BY THE CONTRACTOR TO COMPLY WITH OTM BOOK 7 REQUIREMENTS.

  4. LOCATION AND PLACEMENT OF TRAFFIC CONTROL SIGNS ON PERTH COUNTY ROADS TO BE COORDINATED WITH THE COUNTY OF PERTH.
  5. LOCATION AND PLACEMENT OF TRAFFIC CONTROL SIGNS ON HURON COUNTY ROADS TO BE COORDINATED WITH THE COUNTY OF HURON.
  6. LOCATION AND PLACEMENT OF TRAFFIC CONTROL SIGNS ON MUNICIPAL ROADS TO BE COORDINATED WITH THE APPLICABLE LOCAL MUNICIPALITY.
