1. *The Connection Fee per **UNIT**, as per the current By-Law to establish fees and charges to be collected by the Municipality shall be paid by the undersigned as owner of the above described property.*
2. *All construction required to connect the water and/or sewer service from the main to the property line will be conducted by the Municipality of Huron East. The cost of*

*constructing these services, being 100% time and material, including any road repairs shall be paid by the undersigned as owner of the described property, to the Municipality of Huron East upon receipt of invoice.*

3. *There shall be a valve and/or sewer clean-out installed with every service, at or within 1m of the property line, and shall be the property of the Municipality of Huron East and shall only be operated by the Municipality of Huron East.*
4. *The undersigned, as owner of the described property will arrange and pay 100% of the cost to connect the service(s) from the property line to the building and agrees to conform to all by-laws of the Municipality of Huron East respecting water, sewers, and all applicable building and plumbing code regulations.*
5. *Any and all costs set out in this agreement, if not paid within 90 days from the date of invoice, shall be considered a lien upon the property connected with said water and/or sewer service and shall be collected in the same manner as municipal taxes.*
